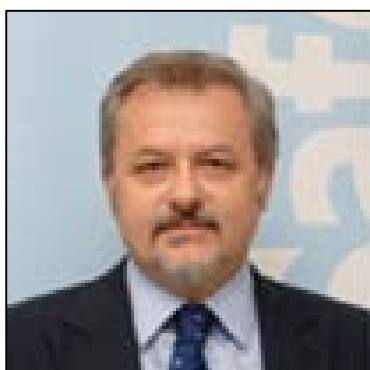
### **Ms. Cloris Pan**
